Petitioners, appearing PRO SE, along with Verified Petition allege as follows:

### Jurisdiction, Venue and Parties:

- 1). Petitioners appearing PRO SE, reside within the geographic limits of the borders of the Village of Lyons, County of Wayne, State of NY; are registered to vote in same, and all signed the original dissolution petition therefore they have standing to bring this action.
- 2). Respondent, Village of Lyons Board of Trustees, is the formal recognized government entity serving the municipality incorporated as the Village of Lyons.
- 3). This proceeding pursuant to Article 78 of the Civil Practice Law and Rules is the proper mechanism for seeking declaratory judgment, compelling action, and granting financial relief per General Municipal Law 17A Sections 773-790 and NY Civil Practice Law and Rules Sections 7800 -7804.
- 4). Petitioners have no other recourse than pursing relief as allowed in CPLR 7804 and GML 17-A. Therefore, this court is the proper venue.

## **Summary of Relief Requested**

- 5). Petitioners seek declaration by the court that the Respondent failed to complete and approve a proposed dissolution plan, as required in "The New NY Government Reorganization and Citizen Empowerment Act" Article 17-A Section 782 within 180 days of December 27, 2012; and was **unable and unwilling** to comply in good faith. Petitioners are concerned that Village behavior and public statements, both past and recently, suggests that non-compliance with GML 17-A will continue without judicial intervention. Petitioners note that per our knowledge, a specific case such as this under GML 17-A has not been heard and is a compelling reason for judicial review.
- 6). Petitioners seek a declaration that the Respondent has failed to comply in good faith with GML 17A section 782 because though Respondent was aware of the vote in favor of dissolution November 6, 2012 (and received notification of the certification of the vote November 27, 2012), Respondent delayed

commencing a Dissolution Committee for the purpose of commencing preparation of a proposed dissolution plan until March 7 2013, 70 days after the formal 180 day deadline clock began. This intentional delay only served to handicap the ability of the Village Board appointed dissolution committee to complete their assigned duties within required timeframes and produce a comprehensive well researched proposed dissolution plan.

- 7) Petitioners seek an order under Section 786 of the law compelling the Village of Lyons to approve a proposed dissolution plan within two weeks of this order, or Petitioners request that the court appoint a Hearing Officer to complete a dissolution plan as described in Section 786 of the law. Delaying the approval and presentation of a proposed dissolution plan to hammer out specifics disregards the larger picture in that the town and potential fire district cannot be bound by the findings and recommendations of the dissolution plan, and will make their own determinations.
- 8). Petitioners seek an order of reimbursement of all costs to Petitioners incurred to pursue this proceeding, and for the village to bear all costs of any Judicial Hearing officer, as allowed under Section 786 of GML 17A.
- 9) If Respondents comply with the law and approve and present a proposed dissolution plan prior to this being judicially reviewed, Petitioners request that relief sections 5, 6, and 8 of this petition still be granted. Such declaration and order affirms statutory noncompliance, that the will of the majority of the voters was ignored without good cause, and the village must adhere to its duties as required under Article 17-A of GML once the process continues forward.

# **Background & Facts**

- 10). This proceeding arises as a result of Petitioners submitting an Elector Initiated Dissolution Petition under GML 17-A Section 779 and succeeding in a ballot initiative on November 6 2012 in which the board received notice November 27, 2012 of the certified results. (**Exhibit A Statement of Wayne CO BOE and Original Petition**)
- 11). On September 25, 2012 the Village of Lyons held a public information session regarding village dissolution, which was presented by NYS Conference of Mayors Attorney Wade Beltrano. (Exhibit B)

Voters and Village Board present were educated about the requirements of the law, including the requirement that after certification of the vote, the board must meet within 30 days. Within 180 days of that meeting, the Village Board must prepare and approve a dissolution plan.

- 12). Village of Lyons belongs to NYS Conference of Mayors, whom Mayor Kleisle reported at the September 25 2012 informational meeting that speaker Wade Beltrano created the village guide for dissolution MMS-Guide to GML17-A Consolidation and Dissolution of Local Government. Page 18 of this guide (obtained off of the public area of the NYCOM website), under commentary, states "Officials should give 1<sup>st</sup> priority to developing a thorough understandable plan, rather than rushing the process merely to comply with the 180 day time period. Nevertheless, communities involved in the process should strive to complete the plan as quickly as possible. As long as village officials work diligently and in a good faith effort to complete the proposed dissolution plan, it is unlikely a judge will interfere in the process, an option which the act provides for and is discussed below." (Exhibit C)
- 13). On November 27, 2012; Wayne County Board of Elections certified the results of the vote and notified the village, creating a duty to meet within 30 days under Section 782 of GML 17-A. The Village of Lyons board convened December 3, 2012 for the yearly Organizational meeting, acknowledged receipt of the election results, and authorized the mayor to advertise for positions on the "Dissolution Committee" with a deadline of December 10, 2012 for Resumes to be submitted. (**Exhibit D**)
- 14.) The village board met December 27, 2012 effectively starting the clock on the 180 day time limit for approval of a proposed dissolution plan under Section 782 of GML 17-A. At that meeting, the Village Board appointed members to the "Dissolution Committee", and authorized an "RFP" process to choose a consultant. The minutes from the December 27 2012 meeting note that the mayor will fill 3 remaining vacancies on the 2<sup>nd</sup> week of January 2013. We also note that the Village of Lyons waited the full 30 days as allowed by law to meet, and could have easily began the process sooner in an exhibit of good faith effort. (**Exhibit E**)
- 15). February 12, 2013 Village Board meeting, (47 days into the 180 day requirement for completing a dissolution plan), the village finishes the final 3 appointments to "Dissolution Committee" and chooses the consultant to MRB Group. (**Exhibit F**)
- 16). February 26, 2012 Village Board Meeting (61 days into 180 day requirement), Village Board holds a meeting to introduce the "Dissolution Committee" and the Consultant MRB. No business towards

completing a dissolution plan is commenced at this meeting. The Mayor acknowledges that the plan must be completed within 180 days commencing December 27, 2012. Citizen Mark Decracker will be videotaping all dissolution meetings. (**Exhibit G**)

- 17) March 7, 2013 Date of first meeting of the Village of Lyons "Dissolution Committee." (70 days into 180 day requirement). Public notified that a website and formal minutes are at <a href="https://www.lyonsdissolution.org">www.lyonsdissolution.org</a>. Mayor Corrine Kleisle setting the tone and priorities of the dissolution committee: Mayor Kleisle stated "But expediency isn't the group's top priority... It's imperative that a plan be a quality product and not compromised due to the time constraints." (Exhibit L Wayne Post Article)
- 18). April 11, 2013 Village "Dissolution Committee" meeting: Committee Chair, Consultant, and Mayor discuss Wade Beltrano's September 25,2012 presentation and reference his statements that the 180 day deadline is only a goal, not an absolute, and that a judge would probably grant leniency to the process. The committee reports on the record that they see their deadline as June 27, 2013. (**Exhibit H**) Minutes 02:30 to 08:40 of the April 11, 2013 part II video.
- 19). June 6, 2013 Dissolution Meeting: (**Exhibit I**) Minutes 25:37 26:57. Question asked "When is the deadline. Chair reports there is no deadline, only a goal which is June 28<sup>th</sup>." Mayor and consultant are present and do not correct this misinformation. Chair reports they will not meet the "goal" deadline. Chair notes there will be no meeting next week.
- 20). June 13, 2013 Dissolution Committee meeting: The committee chair informs the board and public that they anticipate completing the proposed dissolution plan sometime in late July or early August. There is disagreement over public safety and there will be delays once this is turned over to the consultants. Per the dissolution committee website maintained by MRB Group, the village is only half way through their created process timeline as of this meeting. (**Exhibit J**)
- 21). June 23, 2013 Dissolution Committee Official Website @ <a href="http://www.lyonsdissolution.org/">http://www.lyonsdissolution.org/</a>
  discussing that the plan will be late, the committee chairman considers the statutory deadline an arbitrary date, and that it's possible a draft will not be available to present to the Lyons Village Board until August 1, 2012: "When asked about the likely date of completion of the Dissolution Plan, Committee Chair Sergei Bartishevich indicated that it is unlikely the June 27 deadline can be achieved. He called it a "target date," but stated that he believed the need for thoroughness and completeness of the plan outweighed an arbitrary deadline." While State Statute clearly defines a 180-day period for "approval" of a dissolution plan initiated by a public referendum, the same statue also provides a strict schedule of public notifications and opportunities for public input

throughout the process of its creation. The committee reviewed a calendar and established that, given completion of a draft by August, it would still require several public notices, meetings, and required hearings to satisfy the law. Bartishevich stated that it would be premature to discuss a final date." This update from MRB Group's Official Dissolution Committee Webpage further illustrates that Respondents do not plan to finish discharging statutory duty until late August, 6-8 weeks past the required deadline date. It further shows that **if** the Village of Lyons Board had started working in good faith on a proposed dissolution plan immediately upon learning the results of the vote, they may have been able to complete the process within the required timelines. Further, the updated process update shows the committee is still only half way through the process set by the Village Board and MRB Group consultants for creating and approving a proposed dissolution plan. (**Exhibit K**)

- 21). June 25, 2013: The actual statutory 180 deadline passed and the Village of Lyons failed to comply with GML 17-A duty to complete and approve a dissolution plan. Deadline began December 27, 2012 (which was at the 30 day limit of the formal certification of the vote) and ended June 25, 2013 (which is by direct count 180 days counting December 27, 2012).
- 22). June 27 "deadline", initially given by the Dissolution Committee, the Village of Lyons, and MRB Group as their estimated 6 month deadline, has passed without a proposed plan. This plan is a PROPOSED plan that still will require public input, may lead to a vote, and ultimately will fall to the Town of Lyons and any created fire district to follow as they see fit. Failure to complete this plan within timely limits unnecessarily delays a voter initiated and approved process. Further, failing to complete the PROPOSED dissolution plan will negatively impact Town of Lyons and Village of Lyons budgetary planning processes, future capital projects to fix infrastructure, clearly violates the spirit of the Elector Initiated Dissolution Law, and ignores the will of the majority of the voters within the village of Lyons. It further negatively impacts the employees of both government entities and their ability to plan for change, continues to maintain high taxing burdens, and directly harms the will of the majority of voters affirmed via ballot.

# **Basis for Relief**

23). The Village of Lyons is by Legislative Statute legally bound to complete and approve a proposed dissolution plan within 180 days of the December 27, 2012 village board meeting. They have failed in that duty. Reference GML 17-A Section 782.

24). The GML 17-A law Section 786 authorizes any five (5) Electors who signed the petition to commence a special proceeding to compel compliance, and to determine if the Village acted "in good faith" or were "unwilling and unable" to complete the proposed dissolution plan. Based upon the public record that the village was aware of their duty since at least September 25, 2012; AND the Village waited 70 days out of 180 days before beginning work on a proposed dissolution plan; AND the taped public discussion of both the 4/1/2013 and 6/6/2013 Dissolution Committee meetings, stating that this was a goal not a requirement, and noting a belief that a judge would grant leniency for failing to obey the law; the Petitioners are within their rights to request the court to declare that the village failed to act in good faith to complete their duties, and showed they were unwilling to complete the statutory duties within the required 180 days.

### AS AND FOR CAUSES OF ACTION REQUESTED

The failure of the Village of Lyons Board of Trustees to prepare and adopt a proposed dissolution plan is an intentional failure to discharge a statutory duty showing they were unable and unwilling to complete statutory duty within required time frames and that they did not act in good faith to meet the required deadlines. Further, the consultant the board chose to implement the process had already been on public record via the media as hostile to dissolution, was actively involved in the RFP requirement selection process prior to a consultant being chosen, and calling into question the entire process and motivation to show good faith effort to discharge contractual duties due financial and ethical conflicts of interest.

- 25). Petitioners re-allege paragraphs 1through 24 as fully set forth here-in, and further allege:
- 26). The Respondents were fully aware of the legal requirements and their duties under the law as of at least the September 25, 2012 Informational Hearing held by NYCOM General Counsel Wade Beltrano on the Village of Lyons behalf. The respondents had access to a retained village attorney as well as NYCOM General Counsel Wade Beltrano, who the mayor reports "He's the expert on dissolution." While having full access to expert legal advice on dissolution, the Lyons Village Board failed to discharge statutory duties under GML 17-A.
- 27). On September 25, 2012 the Mayor of Lyons referenced the village handbook they were using for guidance during the dissolution proceedings, and noted Wade Beltrano was the author of it. This matters

to this case because legal commentary in the handbook notes that "Officials should give 1st priority to developing a thorough understandable plan, rather than rushing the process merely to comply with the 180 day time period. Nevertheless, communities involved in the process should strive to complete the plan as quickly as possible. As long as village officials work diligently and in a good faith effort to complete the proposed dissolution plan, it is unlikely a judge will interfere in the process, an option which the act provides for and is discussed below." (Exhibit C). As previously established in the factual record, the legal opinion was quoted many times during the last 9 months, creating and later illustrating an official belief that the statutory deadlines were not mandatory because a judge would grant leniency to the process. The legal opinion supposing foreknowledge of Judiciary Action further shows along with cumulative evidence that a good faith effort to meet the deadlines in an expeditious manner was not given because legal counsel advised and village officials repeatedly asserted that judicial leniency would be granted and any challenges would be a moot point.

- 28). Respondents were quoted in the public record as early as August 2012 and continuing through and after the November 6, 2012 dissolution vote, as being hostile to dissolution. (**Exhibit L**) The Lyons Village Board Trustees and Mayor actively campaigned against dissolution in public and in the media prior to the November vote for dissolution. Via public statements and media interviews, Mayor Corrine Kleisle and many members of the Village Board of Trustees showed hostile opposition to dissolution, frustration with results of the vote, and a motivation to delaying further implementation of Article 17-A duties.
- 29). The consultant chosen by the Lyons Village Board to guide them through the dissolution process is not without potential financial conflicts of interests, compared to the competitor Center for Governmental Research, and was actively engaged in the terms of the "RFP" process. (**Exhibit M**) Being that our FOIL request only captured part of the behind the scenes communications between MRB Group and the Village, this calls into question the integrity of the selection process and shows a bias towards MRB as the contractor due to previous financial ties and questionably close assistance during and after the dissolution vote and throughout the RFP process selection.
- 30). Further, it is well established in the Village of Lyons financial reports that MRB Group has been the contractor and consultant of choice for the Village of Lyons and stands to lose tens of thousands of dollars in yearly village business. We assert that this is a financial motivation for MRB to see dissolution of the Village of Lyons fail as they might not be reselected as the Town of Lyons consultant/contractor.

- 31). Further, the "Dissolution Consultants" **MRB Group Strategic Municipal Initiatives** Diana Smith and Connie Soward further revealed open public opposition to dissolution, and via email communications after the November vote revealed strong empathy against the results of the vote. (**Exhibit N**) This open public hostility to dissolution further calls into question the objectivity of MRB Group in faithfully advocating the statutory requirements of the law and correcting inaccuracies when they occurred with regards to statutory deadlines and official village positions. Further, per Mayor Kleisle at the February 26 Village of Lyons Board meeting, MRB further refined the process, outlined originally by NYCOM Wade Beltrano, and provided guidance to the Board of Trustees and to the Dissolution Committee. MRB also directly maintained the official Lyons Village Dissolution webpage at <a href="https://www.lyonsdissolution.org">www.lyonsdissolution.org</a>.
- 32). Further, MRB Consultant Diana Smith was the former Mayor of Seneca Falls and publically opposed to dissolution in her village. Diana Smith was also a former Executive Committee member of the NYS Conference of Mayors which officially opposed the Government Reorganization Act. (**Exhibit O**) This calls into question the existence of conflicts of interest in objectively consulting for the Village of Lyons during the dissolution process and promoting a good faith effort to encourage the Village of Lyons to complete the process in an expeditious manner as required by law.
- 33). Further, the "Dissolution Consultants" Diana Smith made public statements to the media showing predisposition against dissolution and motivation for a lack of good faith effort to complete the entire Article 17-A process in an expeditious manner. (**Exhibit P**). Quoting consultant Diana Smith: "I call dissolution in our village the toughest thing to ever derail the community," said Mayor Diana M. Smith, an opponent of dissolution. "Really, from the time that discussions began to now, we very often refer to it as the runaway train. From time to time, we feel it ran over us."
- 34). In regards to presenting a good faith effort to discharge statutory duties, The Village of Lyons did not have to wait until December 27, 2012 to begin the dissolution process and appoint committee members. We re-assert that the vote certification occurred November 27, 2012 and that the Village Board waited the full 30 days allowed by law to meet and officially begin the process of creating and approving a proposed dissolution plan. The December 3<sup>rd</sup> minutes note that the Village Board was accepting applications for a dissolution committee with a return deadline of December 10th. Instead of timely seating a dissolution committee and expeditiously starting the process at both the December 3 and December 27, 2012 meetings, the Village of Lyons Board waited until March 7, 2103 to actively engage and start the dissolution committee process as dictated by the village board. This 70 day delay effectively handicapped the Dissolution Committee from completing their duties within the 180 day deadline.

- 35). Per Wayne Post article covering the March 7, 2013 Dissolution Committee meeting, it was Mayor Corrine Kleisle who selected the final nine members of the dissolution committee herself after receiving over 20 applications. (**Exhibit L Wayne Post Article**) Per established Village Board minutes and media articles, the Village Board waited from December 10, 2012 until February 12, 2013 to complete the appointments to the "Dissolution Committee." This was a 47 day delay from the December 27, 2012 statutory deadline start and is not explained in any village minutes as to why the delay. Having established Mayor Kleisle was opposed to dissolution and opposed to a statutory deadline, we assert that Mayor Corrine Kleisle led the delays in appointing a dissolution committee, thus leading to delays in the Lyons Village Board of Trustees approving the appointments.
- 36). On at least two (2) occasions, April 11 2013 and June 6 2013, Mayor Kleisle and the consultant failed to correct the statements of the Dissolution Committee Chairman that there was NOT a statutory deadline and instead the committee only had a "goal" to complete their work within 180 days. (Exhibits H & I) Further, MRB's Official Dissolution Committee Webpage classifies the statutory deadline as "arbitrary." (Exhibit K) This repetitive intentional failure to correct open misinformation in a public forum further shows evidence of both Village Officials and the Consultant intent to circumvent and ignore the statutory deadlines using the premise that the deadline is "arbitrary" and the Respondents did not have enough time to complete the process, and as such raises ethical questions for public official misconduct in fulfilling statutory duties and advocating adherence to the law.
- 37). The cumulative evidence in the media and public records for the Mayor, members of the Lyons Village Board of Trustees, and the chosen Dissolution Consultants shows an open hostility towards both the results of the vote, dissolution itself, and illustrates a unified belief that strict adherence to the GML 17-A was unnecessary because "judicial discretion" would grant leeway for any deviations. This theme was repeated many times in many variations, and does not support any assertions that the Village Board/Mayor/Consultant acted in good faith to discharge their statutory duties. Instead, the cumulative evidence shows that the Village Board repeatedly was unwilling and unable to discharge their statutory duties and did not put forth a good faith effort towards doing so.
- 38). Further, the cumulative evidence of board actions, public and 'private' email communications, as well as media statements combine to support Petitioners request for judicial intervention to grant the requested relief because the Village Board of Trustees and Mayor are knowingly and willfully UNABLE and UNWILLING to perform their statutory duties. Further, the email communications captured via FOIL requests and FOIL appeals only show what we believe was a small portion of ex-parte

communications between the Respondents and MRB. We assert that even this small sample clearly illustrates the totality of evidence in support of our allegations.







5. Permit Applications. Excepting only activities undertaken to protect public safety because of emergency conditions or incidents, Permittee shall provide timely written notice to NYSDOT of operations or activities affecting state right-of-way. Under normal circumstances, a minimum of five business days' notice shall be provided. Notification of emergency activities shall be provided to NYSDOT as soon as practicable after the activity. The Permittee shall apply for project-specific permits for activities not allowed under any existing annual permit. Such application shall identify proposed project locations, desired dates/hours, proposed work/activities, traffic control, and site restoration

- 2. Applicable Rules, Regulations & Conditions. Permittee shall comply with all of the laws, rules and regulations applicable to construction, maintenance activities and operations and shall further comply with such terms and conditions that may be imposed by NYSDOT in connection with permitted activity or operations. Temporary Traffic Control, highway safety appurtenances, and restoration of state facilities shall be completed in accordance with NYSDOT regulations and standards.
- 3. Site Restoration. Permittee shall, at its own expense, promptly complete the work allowed under each permit and, within a reasonable time, restore State property damaged by its work/activities to substantially the same or equivalent condition as existed before such work was begun as determined by the Commissioner or his/her designee. In the event that the Permittee fails to so restore damaged State property within what the Commissioner deems to be a reasonable time, the Commissioner, after giving written notice to the Permittee, may restore the property to substantially the same or equivalent condition as existed before the Permittee's work/activities, in which case, Permittee agrees to reimburse the reasonable expenses in connection therewith.
- 4. Payment & Release of Liens. Permittee shall be responsible for the payment of all costs and materials relating to its work in the public right-of-way, and agrees to defend and save harmless NYSDOT against any and all lien claims made by persons supplying services or materials to Permittee in connection with Permittee's work
- 5. Indemnity. In addition to the protection afforded to NYSDOT under any available insurance, NYSDOT shall not be liable for any damage or injury to the Permittee, its agents, employees, or to any other person, or to any property, occurring on the site or in any way associated with Permittee's activities or operations, whether undertaken by Permittee's own forces or by contractors or other agents working on Permittee's behalf. To the fullest extent permitted by law, the Permittee agrees to defend, indemnify and hold harmless the State of New York, NYSDOT, and their agents from and against all claims, damages, losses and expenses, including but not limited to, claims for personal injuries, property damage, wrongful death, and/or environmental claims and attorney fees arising out of any such claim, that are in any way associated with the Permittee's, activities or operations under any and all permits issued using this Undertaking. FURTHERMORE, Permittee hereby warrants that the obligations of this Undertaking are backed by the full faith and credit of Permittee. Permittee may insure or bond any of the obligations set forth herein, or may rely upon self-insurance, budgeted funds, or funds for general operations.

This Undertaking shall be applicable to all permitted activities and operations undertaken after the date of execution and work initiated while this Undertaking is in effect. This Undertaking may be revoked by the Permittee or rejected by NYSDOT upon thirty days written notice but will continue to apply to all permitted activities/operations that were permitted by virtue of this Undertaking. Unless terminated for the purpose of future activities/operations, this Undertaking shall have a term of twenty (20) years and shall be kept on file to facilitate the issuance of future permits to which it will apply.

Absent: James Brady. She thanked all of them for agreeing to be a committee member. It will be a difficult job and will be very time consuming. It is a working committee.

All members have assured her that their findings and recommendations will be the needs of both the Town and the Village. This will not be personal feelings as to the Village should be dissolved or not. They will work on a plan that will make it the best it can be for all the people in the Village and all the people in the Town. She feels the committee is an unbiased group that will come up with a very good plan for the Dissolution. The Committee will make progress reports to the Village Board monthly. The Village will provide all and any information, records, everything the committee needs to do an appropriate plan.

The choice of people on the committee recommends that it consist of the Village Mayor, representative from the Town, representative from Municipal Labor Unions, balance of committee made up of residents from business owners, property owners from the Town and the Village. Mayor feels our committee is good cross sections from our community.

The plan must be done within 180 days, commencing December 27, 2012. This will bring us into the end of June 2013. The deadline is very important for us to complete a plan for the dissolution. However, it is imperative that the plan be a quality product and not compromised because of the required time constraints. We will all work to meet that deadline, but will also make sure what is presented at the Public Hearing is a good plan.

This committee will be required to address the following issues:

Name of the Village, our boundaries, type and class of the Village, a fiscal estimate of the cost of dissolving the Village, any plan of transferring or eliminating positions of public employees, review Village assets, including but not limited to real and personal property, address Village's liabilities and indebtness, bounded and otherwise and it's fair value, review any agreements entered with towns or any government agencies, the manner and means by which municipal services will be continued followed by the dissolution. Terms of disposing the Villages assets, liabilities and indebtness, including the levying of taxes. Pay off any liabilities. Findings as to any Village Local Laws and ordinances remain in effect after the dissolution for a certain period of time.

At the first meeting of our committee, a chairman will be elected and a Deputy. People will be appointed to subcommittees for Public Safety-Fire and Police, Public Works, Water & Sewer, Administration, Financials, Courts, and Zoning and Codes.

At the last Village Board meeting, the Village Board appointed MRB/group to be our consultant in this dissolution process. Diana Smith and Connie Sowards were introduced to the committee.

Diana Smith gave an overview of MRB/group and their role. They will utilize the expertise and recommendations of the Dissolution Committee who have been charged by the Mayor with the responsibility of analyzing services provided by both the Village and Town, then planning for the optimal dissolution path, and finally examining the fiscal impacts of dissolution which include recognition of the actual costs anticipated to be created by the dissolution process, as well as recognition of the incentives which the state has made available.

They see their role as being a guide that supports the Committee in the gathering and interpretation of data, in the discussions about services and optimal delivery, in the analysis of the fiscal impacts of combining services, in the exploration of alternatives, and finally, in preparation of a report which is focused on the critical elements and communicates effectively the considerations taken in this effort, so that the residents of Lyons understand the discussions and their implications. Most importantly, they hope they can help the committee retain an objective approach to determining what's in the best interest of the community.

She explained the toughest task of the committee will be to suspend their discussions and deliberations on whether the Village should dissolve and instead focus on a creation of a plan that is optimal.

Connie Sowards discussed the process and responsibility of the committee. Notebooks were handed out to get the committee started. Diana Smith reviewed the timeline for the dissolution process. MRB /group is fully prepared to meet the statutory guidelines set by Article 17-A. Diana Smith reviewed the duties of the Committee Chairperson. 



### Dissolution Website and Video of 4/11/2012 Dissolution Meeting










Establishing the current status reports and plan process as June 16, 2013. Based upon the committee updates and the formal website progress reports, Lyons is only ½ through the process.

# **Tough Decisions Ahead After Dissolution Vote in Lyons**

If the current margin holds up, residents in the Wayne County village of Lyons will have voted to dissolve a village government that's been around for nearly two centuries.



The village of Lyons was incorporated in 1831. Dissolving it may have taken just one vote.

On Tuesday, village residents were asked to decide whether to dissolve the village of Lyons and its government into the town of Lyons. Yes votes outnumbered no's by a count of 45.

"I'm surprised," said Corrine Kleisle, mayor.

Kleisle grew up here. She's at a loss.

"I just don't understand how people can give away that history."

"You're going to save money, there's no way around that," said Jack Bailey.

The push to dissolve the village was spearheaded by Jack Bailey, a local minister and former elections commissioner who believes the move will save taxpayers money.

"A lot of it is due to duplication of services and we felt that eliminating a layer of government which the town could adequately cover for us would make it more efficient and reduce costs."

The mayor says there's no proof dissolution will add up to savings.

"The majority of people voted to dissolve without any concrete plan, without an actual savings," Kleisle said.

The effort to look into dissolving the village of Lyons began over the summer. Signatures were collected on petitions. Informational meetings were held.

"I think village residents have been very engaged in the debate," said Bailey

The dissolution of the village of Lyons isn't a done deal, yet. Ninety-nine absentee ballots must still be counted.

If the vote stands, officials from the town and village have to figure out what to do with the village's 46 full and parttime employees, and all the services provided.

"We need to streamline, be more efficient, reduce layers, and in the end that does reduce tax burdens," Bailey said.

"Ultimately, the town will decide the bottom line. What's going and what's staying," said Kleisle.

Kleisle says tough decisions will have to be made, but in what's now the village of Lyons, life will go on.

"I think people bounce back. Whatever happens they make it work," said Kleisle

### Some ballots still need to be counted.

The Village of Lyons may be going away after a vote on Tuesday.

The results are unofficial, and absentee ballots still need to be counted, but at this point, it looks like the Village of Lyonsmay be dissolved. Voters approved the dissolution on Tuesday, 569 to 524. There are still more than 90 absentee ballots that have to be counted. ## **Dissolution on Ballot for Village of Lyons**

After eight years serving as mayor for the village of Lyons, the proposal on November's ballot is hard to accept.

"There's tradition, there's no need to give away the village," said Corrine Kleisle, mayor of Lyons.

But that sentiment isn't shared by everyone. The petition for dissolution was signed by ten percent of the village's voters.

"History and nostalgia isn't enough reason to keep a tax burden among the citizens of the village. We are Lyons, whether we are a village or a town," said Jack Bailey, a resident.

The crowd at Tuesday's meeting had one question: what's the potential impact? A representative from the New York Conference of Mayors says a dissolution wouldn't necessarily provide more efficiency, but more of a cost shift.

"Right now, village residents pay town taxes and don't necessarily get services in return for that. When the village dissolves, the town now has to pay for the maintenance of the roads, village residents get something for their tax dollars," said Wade Beltramo, New York Conference of Mayors.

If the majority votes to dissolve the village, contracts concerning water, sewer, zoning and public safety services would have to be renegotiated.

Before November 6th, voters are going to have to decide which services they are willing to lose. That means the police presence that residents have come to rely on may no longer exist.

The village police department could be turned into a town department or dissolved completely, putting the burden on the Sheriff's Office.

"Sheriff has already taken the position that he would not be able to provide a police presence equivalent to the village police," said Chief Richard Bogan of the Lyons Police Department.

Dissolved services could also mean a loss of jobs. There's also the issue of village debt and benefits for 46 employees.

But the petition's main purpose, according to supporters, is saving money, which is the one thing that can't be proven. The results of a study conducted by an appointed committee to decide potential savings won't come until after November's vote.

Residents have looked to the dissolution of Seneca Falls' village as a comparison; however, Beltramo says the factors are different, most notably the tax savings village residents gained due to the landfill. Since every village is unique, officials say Lyons voters will have to weigh their options carefully.

"Don't throw away your village. Don't do it because you're mad at us because we didn't fill your pot hole. Have a good reason," said Kleisle.

Suggested Stories Lyons, N.Y. - For the first time in over 40 years, a Wayne County village is designing a plan to dissolve.

The newly formed committee that will formulate a plan for the dissolution of the village of Lyons will meet for the first time Thursday, March 7 at 6:30 p.m. in a workshop that is open to the public. Its progress will be reported to the Village Board on a monthly basis. The last village in the county to dissolve was Savannah some 40 or 50 years ago, Mayor Corrine Kleisle said.

At last Tuesday's Village Board meeting, Kleisle introduced the nine-member committee made up of residents who each have a specific expertise in varying fields that the mayor believed would he beneficial in the process. They include Jim Brady, former county highway superintendent and former village trustee; Thea Hall, executive secretary to the principal at the elementary school; Joan Smith, with the Department of Social Services; Jim Pacello IIT, a local businessman; John Cinelli, a former mayor; Sergei Bartishevich, an active community member; Richard Bogan, Lyons police chief; Brian Manktelow, town supervisor, who will share committee duties with Councilman Dan Legacy; and the final member, Kleisle.

Kleisle said she received over 20 applications from residents interested in joining the committee. She selected the final nine herself.

The committee has until June 27 to develop a dissolution plan. MRBGroup consultants Diana Smith

and Connie Sowards will guide the committee and keep them on a prepared timeline that will ensure they meet the deadline.

But expediency isn't the committee's top priority, Kleisle reminded them.

"It's imperative the plan be a quality product and not be compromised due to the time constraints," she said.

Among the matters the committee has been tasked to examine are: the estimated fiscal cost for the village to dissolve; plans to

transfer or eliminate positions; the village's assets, liabilities and indebtedness; any existing agreements between the village and

other municipalities; the "manner and means" by which services will be provided to village residents; a determination if any local

laws or ordinances will remain after the dissolution for up to two years.

Once the plan is complete and adopted by the Village Board, a public hearing will be held where residents can comment and

amendments can be made to the plan, Soward said. Once amendments, if any, are added, another public hearing is held. After the

final public hearing on the plan, residents may file a petition containing 25 percent of registered village voters signatures for another

referendum. The second vote. which would be on the plan itself. If the second plan, which would be on the plan itself, is approved, the

village dissolves, but if it fails, everything remains the same and there is a four-year waiting period before residents can seek to

dissolve the village again, Soward explained.

Smith offered the committee some words of wisdom as they move forward in a process that requires great patience and "inherently

breeds mistrust." She advised they set aside their personal feelings about the issue of dissolution and pursue a logical path.

"This is going to be an extremely challenging task," Smith said. "This is probably one of the most significant events in the village of

Lyons' history. If people are emotional, it's because they're passionate about the community. Remember to respect each other."

I believe that in RFP-writing, there is a difference between estimating what is likely to be necessary for your own expectations, and **specifying a minimum scope** for the sake of keeping your responses fair, credible, and somewhat equal in expected deliverables.

There are many determining factors, such as how strong a role you and your staff will play in leading the meetings and adhering to the agenda, etc.

As we've discussed before, I believe that the most valuable thing you can specify is a requirement for specific deliverables that include more than just "discussion" of alternatives to dissolution (Seneca Falls' plan included just a few paragraphs) but rather a full evaluation and related financial impacts. Sounds like you're on the right track with being quite specific.

#### TAX AND BUDGET SAVINGS

Mr. Beltramo noted the law doesn't address school districts, counties or cities, which represent 88 percent of the total property taxes paid across the state.

He also said increased efficiency by eliminating one government accounts for only a small amount of the spending and tax savings that come from dissolving a municipality.

"Villages provide different services and different levels of service than towns. They are usually very different from the rural area outside. Usually, you still need people to plow roads, maintain the water and sewer," Mr. Beltramo said. "At best, it will save 5 to 8 percent."

Dissolution savings also come from cutting or restructuring services and eliminating elected officials.

Mr. Beltramo said his research has shown that most of the savings for village residents come from increased revenue from "town outside" residents, and special aid from the state. The state offers an incentive for villages to dissolve, which increases aid to the towns in which they were located up to 15 percent of the tax levy — forever.

"Some people call this a tax shift, and that's what it is," Mr. Beltramo said. "We're in the system we are in, and I don't think a new law is going to make it any easier. If we got rid of the village government, would it really make us all one big happy family?"



# Dissolution is complicated, unpredictable event, Seneca Falls leaders warn

By MATTHEW BULTMAN JOHNSON NEWSPAPERS

POTSDAM — Dissolution was again the topic of discussion Tuesday night in the village, but this time it featured speakers with fresh perspective on the issue.

Three leaders from the village of Seneca Falls — the mayor, village administrator and attorney — presented their thoughts on the issue of dissolution during their presentation titled "Dissolution: The Seneca Falls Experience."

Their message: Dissolution has been a long, drawn-out process, with many more obstacles than anyone could have anticipated.

In March 2010, the village of Seneca Falls voted to dissolve, becoming the largest village in the state to do so. Armed with a dissolution plan and a promise of significant tax breaks, village voters narrowly passed the resolution.

While the Seneca Falls representatives did not give their opinion on the situation in Potsdam, they did give a detailed outline of what they believe to be the problems with dissolution and the pitfalls of the plan.

They spoke of failed labor negotiations as village employees try to transition to the town, the town's hesitancy to work with the village and follow the dissolution plan as well as the difficulty of trying to establish tax districts to pay off debts in the former village.

All in all, they concluded, dissolution was an issue of which no committee could anticipate all the outcomes and effects, no matter how diligently it tried.

"What we're finding is that there are a lot of things that have not been considered prior to the vote in our community," Ms. Smith said. "Of course, hindsight is always 20/20, but now we wonder, had the community known all they know now, would they have felt the same way?"

In its dissolution plan, the Seneca Falls dissolution committee projected a 48 percent tax savings for former village property owners, a number Ms. Smith said drove many village residents to vote in favor of the plan.

But in reality, it wasn't a savings so much as cost-shifting, she said, as much of the burden went from village taxpayers to those in the town.

"Many hands make light work," the mayor said. "You shift the burden onto more people and it becomes less of a burden"

The additional savings, which the town now estimates could rise to as much as 60 percent for village residents, were accounted for in the town's decision to eliminate a number of village positions, many of which village administrators believed were necessary to their daily operations.

"We knew that we were operating on a very lean staff already and had pared back as much as we could," Ms. Smith said.

Both Ms. Smith and Village Administrator Constance Sowards agreed that drafting memorandums of understanding, an agreement with the town outlining how certain issues, such as police protection, would be handled, would have made the transition process much smoother.

But Potsdam Town Supervisor Marie C. Regan has said she and the Town Council are in no position to guarantee residents anything about the future of the town should dissolution pass.

She reiterated those statements Tuesday night.

"How presumptuous would it be for this board to tell you precisely what police protection would look like?" she said. "How it will look, I don't know yet. Everyone will have to have input."

In the end, Seneca Falls village attorney Paul W. Reichel said voters in the village of Seneca Falls may just be beginning to realize the impact of their decision.

"It took a very long time for people to realize this is really going to happen," he said. "Now it has sunk in, and I'm not at village hall every day, but I would say morale is quite low."

SENECA COUNTY, N.Y. -- At the end of this year, four more villages will be added to that list. Three in Cattaraugus County, and one is Seneca.

Seneca Falls will once again make history as the largest village, by several thousand people, to go through the dissolution process.

Diana Smith was the first female mayor of the village where the Women's Rights Movement was born. At the stroke of midnight on January 1st, she'll be the village's last.

"It's an honor I'd hoped I'd never get," Smith said.

In March 2010, village residents voted by a margin of 86 votes to dissolve their government. Mayor Smith called the promised 48 percent tax savings an "incredible enticement."

After 20 months of working to transition services to the town, she believes it is unrealistic.

"The savings that were touted as part of this plan really won't be realized," said Smith. She said the numbers speak for themselves.

Seventy-three percent of the town's residents live in the village. Ninety percent of the municipality's infrastructure that will need to be maintained, is located there as well.

Smith said even the annual two point five to three million dollars in revenue that Seneca Meadows Landfill pays directly to the town, won't cover the expenses the town will need to pick up when dissolution is complete.

"Unfortunately the landfill revenue doesn't cover it all, and that's why for people who live outside the village, they will see their taxes go up considerably," Smith said.

Smith described Seneca Falls Town residents as the, "victims" of dissolution.

She said neither the residents, nor the county had a vote in the state sanctioned process.

According to Smith, and Village Administrator Connie Sowards, the state did not have answers to crucial dissolution questions, either.

"Unemployment insurance for instance, we called the Department of Labor and asked, 'Who's going to pay the unemployment insurance?' And the immediate answer was, 'Well you are,' and we had to explain, there is no us after the 1st of January," Smith said.

"It's just been incredible how many things will just pop up and everyone will say, 'Wow,' we didn't even think of that," said Sowards.

"As we move forward, different challenges will present themselves, and we'll meet those," said Seneca Falls Town Supervisor-elect Donald Earle.

Town Supervisor will be the first elected government position Earle will serve in when he is sworn in December 31st.

Earle said he's been meeting with people involved in the dissolution process, daily.

When YNN asked Earle if he was for or against dissolution, he said, "Originally I was for dissolution. Looking back at things, if things might have been done differently, as far as getting together with shared services, it may not have been necessary, but moving ahead, it is a good thing, because we are one now. It's no more, we and them, us and them, and that's the way we're going to thrive."

As a unified town of more than 9,000 residents, Earle believes Seneca Falls will have a greater voice and better representation at the county and state levels than ever before.

"I really don't feel that we're losing anything in this community. We still have our heritage. We're very fortunate because the name of the village is the same as the town. When people come to this community, they're here in Seneca Falls," said Earle.

"I think it'll be fine, but it is emotional," Sowards said.

Mayor Smith said she does plan to attend the village's annual New Year's Eve ball drop at a local restaurant.

"It's an important community tradition, and I hope people participate. And this year, it's going to be especially symbolic," Mayor Smith said.

# Seneca Falls 'yes' vote holds

Margin narrowed to 86, but village dissolution will move forward

SENECA FALLS — The final margin — 86 votes — has been established, and the 180-year-old village government here will officially dissolve Dec. 31, 2011.

The final, official tally is 1,198 to 1,112.

The Seneca County Board of Elections Tuesday counted the absentees and affidavit ballots. That count added 56 votes for dissolution and 75 votes against. On election night March 16, the margin was 105 votes.

Under dissolution, the town will take over the services now offered by the village.

Town Supervisor Peter Same said the Town Board expects to devote much of its April 6 meeting to dissolution issues.

"We have already made agreements on what services we will take over from the village. We'll make sure that's still the case. I have no reason to think it won't be," Same said. "We will talk about how we will transition those services over to the town."

Same said the board may seek help from the community in the transition process.

In another step, the town will go to the Village Board and ask that it join the town in requesting state legislation to create a police protection district for the current village.

That may be difficult. The Village Board has not been supportive of the police district because it would put the entire cost on current village residents, negating much of the savings from dissolution.

The Village Board prefers a townwide police department using the current village police force.

"I would hope they would join us," Same said. "If so, we will go to our state representatives and ask them to introduce and support this legislation. If the village says no, we're still committed to seeking the legislation, even though it may be harder without the village's support."

He said he's not sure what state Sen. Michael Nozzolio, R-54 of Fayette, or Assemblyman Brian Kolb, R-129 of Canandaigua, would do if only one board approves of the special district.

"We will have to sit down and talk to village officials about services, sooner rather than later," Same said.

He said they will discuss taking over a service before official dissolution to "see how it works."

Mayor Diana Smith, an opponent of dissolution, said the Town Board will be invited to a joint meeting with village officials, possibly as soon as Tuesday night.

"We feel it's important to get the transition process going immediately." Smith said.

She acknowledged the police issue may be difficult. The village is not likely to support the state legislation favored by the town to create a special police district for the village.

"It may be up to the town to pursue that on its own. But the traditional home rule process may be different in this case because the village will cease to exist," Smith said.

She said Same and town officials face a dilemma of making town residents outside the village unhappy by having a townwide police department or angering current village residents with a special police district.

"I still have concerns about service levels with the proposed staff cuts," Smith said. "We have cut five positions in six years and are at a barebones level and the town wants to cut a few more."

Smith said the dissolution vote has been "traumatic" for some village employees concerned about their future. The final vote for Fourth Ward trustee shows David Delelys with 403 votes and incumbent Timothy Masino with 325.
